1. The Government of Nepal *has allocated funds* towards the cost of **Construction of Manmohan Memorial Hospital Building, Lalbandi-06** and intends to apply part of the funds to cover eligible payments under the Contract *for NCB/25/2078/079*. Bidding is open to all eligible Nepalese Bidders.
2. Lalbandi Municipality, Lalbandi Sarlahi invites electronic bids from eligible bidders for the **Construction of Manmohan Memorial Hospital Building, Lalbandi-06** under National Competitive Bidding-Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs-6.4 Crores**
 - Minimum Work experience of similar size and nature: **2 Hospital Building Projects, value of each to be not less Than NRs-6.8 crores within last 10 Years.**
3. Eligible Bidders may visit PPMO e-GP system www.bolpatra.gov.np/egp.
4. Bidder must submit their bid electronically by download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document of the Project's Rs 5,000.00 at Rajaswa (revenue) account as specified below.

5. Bidders must submit electronic bids only through PPMO's e-GP system www.bolpatra.gov.np/egp **on or before 12:00 PM** on before 2078/10/27. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 2078/10/27 at the office of Lalbandi Municipality, Lalbandi, Sarlahi. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs 23, 00,000.00** which shall be valid for 30 days beyond the validity period of the bid.
